ABOUT TEXAS WOMEN FOR THE ARTS

Texas Women for the Arts (TWA) is a statewide giving circle and membership program whose mission is to awaken and nurture the artist in every Texas child. Established in 2005, this philanthropic force of influential women from across the state has awarded more than \$2.9 million to 208 arts organizations, impacting more than one million Texas children.

GRANTS

Every year, Texas Women for the Arts members have the opportunity to nominate and select an arts education program to receive a TWA grant. This funding provides essential support for the arts and increases access to arts education for children in Texas.

MEMBERSHIP DETAILS

The Texas Women for the Arts membership year is from **September 1st to August 31st**. However, memberships are accepted at any time during the year. Membership dues may be paid in a lump sum or quarterly installments. Dues may only be prorated after the Texas Women for the Arts Annual Meeting.
